## A. Information on the declaration and the packaging

### 1. No (unique identification of the packaging)

EU declaration of conformity No **PPWR-2026-S05**.

Unique identification: product series "Filament-reinforced paper packaging tape", comprising all packaging tapes placed on the market by the producer under article numbers with the prefix "PR" that conform to the specification described in A.2. The complete assignment of article numbers results from the producer's ERP system; the batch identification of each delivery results from the roll label or the delivery note.

### 2. Packaging

Self-adhesive packaging tape for sealing medium-weight and heavy cartons (packaging component). Backing: filament-reinforced paper, backing thickness 90 µm, total thickness 135 µm, paper grammage 60 g/m<sup>2</sup>; adhesive: synthetic rubber with hydrocarbon resin; colour: brown. Versions: unprinted and printed (factory designs and customer-specific print designs). Roll dimensions (width, length, core diameter) according to the respective article specifications. The tape is not intended for direct contact with food.

### 3. Producer

This declaration is issued by Herberger & Terzija GbR as producer within the meaning of Art. 3(1)(13) of Regulation (EU) 2025/40. For customer-printed versions, producer status pursuant to Art. 3(1)(13)(b) in conjunction with Art. 15(12) applies vis-à-vis customers that are microenterprises within the meaning of Commission Recommendation 2003/361/EC.

## B. Declaration of conformity

### 1. Object of the declaration

This declaration relates to the filament-reinforced paper packaging tape described under A.2 in the article numbers (prefix "PR") and versions identified under A.1.

### 2. Declaration

The producer declares under its sole responsibility that the packaging identified above complies with the applicable requirements of Articles 5 to 12 of Regulation (EU) 2025/40 on packaging and packaging waste, insofar as those requirements apply to the packaging at the time of placing on the market; this includes in particular the substance requirements under Article 5, including the sum limit of 100 mg/kg (100 ppm) for lead, cadmium, mercury and hexavalent chromium.

## C. Basis of the assessment

### 1. Standards, specifications and documents applied

At the time of issue, no harmonised standards (Art. 36) and no common specifications (Art. 37) under Regulation (EU) 2025/40 have been published. The following documents were used for the assessment:

- Technical data sheet "Paper · reinforced" (tapemonster.de, ref. 268), version 08/2026
- Substance conformity assessment by Herberger & Terzija GbR against the requirements of Articles 5 to 12 PPWR dated 05.08.2026 (heavy metals, PFAS, REACH/SVHC, POPs), documented in the technical documentation under Annex VII
- Declaration on heavy metals of Herberger & Terzija GbR dated 18.06.2026; declarations on PFAS and POPs dated 19.05.2026 (internal assessment basis)



## 2. Technical documentation

The assessment is based on the technical documentation kept by the producer in accordance with Annex VII of Regulation (EU) 2025/40 (Module A – internal production control). It comprises in particular information on the material and construction of the tape (backing, adhesive, printing inks, reinforcement), information on substances contained and applicable substance restrictions under Art. 5 PPWR (heavy metals, PFAS, POPs, REACH/SVHC), and supporting evidence and specifications relating to the product series identified under A.1/A.2. The tape is not intended for direct contact with food; the PFAS restrictions for food-contact packaging therefore do not apply. The technical documentation and this declaration are retained for five years from the day of placing on the market (Art. 15(3)(a) PPWR).

## D. Notified body and signature

### 1. Notified body involved

Not applicable. Conformity assessment is carried out by way of internal production control in accordance with Annex VII (Module A); no notified body is involved in this procedure.
